
better things.

# Past Presidents Report . . .

- October 12, 1955 - ten days later sent 200 letters. First meeting — 17 people attended. Hopes and dreams of Albert Scott were beginning to be materialized. A road - your car, truck or boat could travel and a place to launch your boat.

1957-1958 Oakley Jordan 170 members - Thanksgiving Day - First Derby. in cooperation with the Lions Club of Rocky Point the Cholla Bay Sportsmen Club provided Polio shots for school children. Paid for road grader that was built in 1956. Assets in treasure - \$1,132.00.

1958-1959 Bill Hammer The Cholla Chatter Magazine was started by Bill Valentine. Road graded weekly. Parking lot was built. Ramps from boat landing were paved.

1955-1957 Albert Scott Organized Club 1959-1960 Paul Schoonover Tractor was donated to grade the road. Ship-Shore Radio promotion, donations - \$395.00. Tide Chart for Cholla Chatter by Lyn Bayless. Charts of Area were made of the upper one third of the Gulf. Clothing Drive for flood victims - Marge Klaver, chairman, First Annual Derby Issue.

> 1960-1961 Bill Blair Over 600 current members. Radio permit was issued Bob Taylor, chairman reported. Chapter in Tucson was started - over 200 attended-Elected Wayne DeVore, president, Clothing drive. Cholla Bay Sportsmen's Club Articles of Incorporation and By-laws were changed. Spanish classes organized by H. B. Kelley. It was estimated between 500-700 persons attended the Labor Day Derby. Floor was poured for new Club house.

#### Green Turtle Versus Green Diver

The first turtle I speared is one turtle just above his tail. Now let me tell you, I'm sure I will never forget. The event took place in the summer of '57. John Moore, my brother Bud, and myself were spearfishing along the coast halfway between Sandy Beach and Pelican Point. It was our first summer of ocean diving and everything was new and exciting. We had reached the point in our diving where we were about like the motorcycle rider get-

ting ready for his first fall.

We had been having a ball that day. The water was beautifully clear, warm, and calm and we had been spearing quite a few 5 or 6 lb. grouper and pinto.. I spotted a boil of bait fish about 300 yds. off shore. I decided to try to get in the middle of it and spear some mackerel. I was free diving - no tank, just a mask, snorkle, fins, speargun, and float. I succeeded in getting into the boil and was swimming about 8 ft. under the surface when I spotted a trutle below me about 8 ft. I saw him and took a shot at him. I didn't have any idea that I could penetrate his shell and when I heard the spear clang on his shell I headed up for the surface. About the time I reached the surface the line came tight and the battle was on. The point had penetrated his shell

when you spear a turtle in the tail end he doesn't like it one bit and he poured on the coal! I did likewise and headed for my float anchored about 50 vds, away. The water was deeper than my spearline and he tried to sound. As I pulled it lifted his tail up and he could only swim straight down. That 50 yds. was the longest 50 yds. I ever saw and when I reached the float I was so beat all I could do was hang on and gasp for air. The turtle, however, was just warming up. We drug anchor and started out to sea. I decided I had had enough and would have cut the line but I had pulled a fool trick and left my knife on shore. I wasn't going to turn loose of that speargun so I just hung on, puffing and panting for air. I waved for John and he saw me heading for Rocky Point at a good clip so he took off after me. He finally caught up with me and between the two of us we got the gun tied on the float and swam down to the turtle and looked the situation over. We came up to the surface and decided we would try the method we had seen on T.V. You just swim down and grab the turtle by the shell, head him in the direction you want to go and the turtle does the rest. It really worked fine and in no time Mr. Turtle swam us to

The turtle weighed about 60 lbs. and we really thought we had done something! I have since speared several turtles but I sure have been careful which end I hit. When they are hit in the front they are no trouble to handle. So just remember never shoot a turtle in the back!

Seriously though, there are several lessons to be learned from this experience which could have cost me my life.

- 1. Never work yourself to exhaustion in the water.
- 2. Never dive without a knife. If I had of entangled a foot in my spearline I could have drowned.
  - 3. Always have a buddy with you.
- 4. Remember, you can always buy a new gun. Several divers have been drowned by being so stubborn that they would not turn loose of their gun.

Good Luck, Fisherman



Every year about Derby time, I have to start crying in my beer - reflecting back to past Derbys where fame and fortune eluded my hot little hands, due to the fickle finger of fate.

For the vast multitude of fellow anglers and anglersses, I am going to relate a few of the nauseating experiences which seem to dog my footsteps, year in and year out, with very few exceptions - just as I know you have experienced also.

To-wit - the first time I really messed up, was when our Tucson buddy, Gaynor Stover was chairman of the first annual Mexican Lions Club Derby. They had one helluva nice selection of trophies and prizes offered for all categories, among which I chose to try for the mackerel trophy. Well, now, just about anybody can catch macks, but from previous experience, I figured that I could catch onto some big babys down off the Southern tip of 'Old Fragerant,' Bird Island. In those days, not too many fishermen knew about the nest of big macks that hung out in that vicinity.

Derby day dawned bright and cheerful with nary a puff of wind to mar the placid surface of that beautiful gulf. My buddy, Sorerump Neal and I gaily slud our little 141/2 Miss Maricopa off the trailer into Lishhead Bay, checked our ample supply of fuel, kicked her in the keister and went roaring around the point headed for distant Bird Island and a mell of a hess of king mackerel.

for sea-trout, so our plans were to pull and a whippy rod, you got fun.

into St. Georges Estuary, sack up a load of prize-winning trout, then buzz on out the 9 miles to the island to gather in the trophy macks and then on home to check in our monsters by 6 o'clock deadline.

With a 25 HP motor and a smooth sea, that little old boat could really skat, so we beached in St. Georges Slough after a little over an hour and 15 minutes running time. 'Bruised Bucket Neal and I unlimbered our casting rigs and proceeded to cover every damn inch of that barren beach. We tried every jig in our boxes and I even tried a beer opener with a hook on it, all to no avail - the trout just weren't there. After an hour and a half of fruitless wading and casting, old Ripplerear exclaimed 'to hell with this' I agreed. We reloaded into the boat and eased on out of the slough, empty handed, to try our luck on the macks.

In the interval of time we had spent fruitlessly flinging jigs for corvina, a nice healthy breeze had sprang up from the North, making the crossing to the 'snow' covered island just a mite uncomfortable, for the little boat. Old Ironbutt Neal sat (or tried to) on the front seat to hold the bow down and I ran the rig from the rear where experience had taught me was a helluva lot smoother riding than the remote control setup in the front seat.

We were two damned determined fishermen to get there in one piece, that is, by the time we reached the leeward side of the island.

We both tossed No. 17 Accettas over the side of the boat when we hit smooth water at the southern tip of the rock and commenced to begin. Our hunch was 100% keerect. I'll bet we hadn't trolled more than 100 yards, when we both had reel screeching strikes - man, you can say what you wan to about mackerel fishing but when you hook into the jaws of a mean, fightin' mad old king, with nothing There was also a nice string of prizes between him and you but 18 lb. test line

Well, to shorten up this bunch of jabber a little, I'll just say that old pimple posterior and I loaded our little boat with a nice big slimy stinking bunch of king macks, before it finally dawned on us that were one long, long way from the weighin scales and it was going to be nothing but uphill all the way back. We had done all of our fishing in the lee of Bird Island and hadn't realized that the wind had been busy building and obstacle course for our benefit between us and Cholla Bay.

We battened down our hatches, poked our purty little bow around the island into the teeth of the wind, and started bouncing our way back toward home and a good healthy shot of requilla. We started back, hoping to reach the bay by 6 p.m. and figgered we had just about enough time to make the deadline.

I know that old Bruisedbucket Neal will never forget that wild ride - I know that I sure as hell won't. We hit the top of about every third white cap in our frenzy to make it in time, and old Bob was yelling and cursing me at every bumy, but was afraid to let go of the seat to which he was hanging for dear life, to come back and clobber me.

We finally limped up to the weighin scales, long on fish but short on time, as it was 6:15 and Derby rules stated emphatically 6 a big o'clock. The trophy winning mackerel of the derby as I recall (with a sour taste in my mouth), was just a shade over 7 pounds. Old Gaynor felt as bad about it as we did, when just for the hell of it we weighed 6 of our biggest macks. The smallest of the 6 weighed 71/2 and the rest ranged up to just a hair under 10 pounds.

That's just about the story of my lifeonly it's usually "too little" as well as too

The next fiasco I loused myself up in, darned near made me decide to repudiate the Boy Scout oath (which I of course, dililgently adhere to).

This time was during the Derby old Willy Bill Hammer officiated in. Not having a cabin at that time, I had made an oakie-type camp over at Sand Beach. along with my patient little family and eagress type wife. I unselfishly devoted the first Derby day to my charming licky little family, figuring that the second and last day, old Daddy-o would leave the family in camp while he, the great hairry fisherman that I am, would undoubtedly snare the seatrout division trophy, cause I knew where some big old grandaddy corvina hung out (as I had caught some the day before the Derby started - weighing up to 7 pounds). I poured all the kids and my personal little sexpot wife (she reads this too) into the 'Afrikan Queen' and spent a rather pleasant but not very fruitful day. I was holding back my tremendous capabilities so as not to strain myself for the following days slaughter. After loading the Queen back at the landing, exchanging pleasantries with the jolly semi-natives of Cholla Bay, we headed back to the slums of Sand Beach where popa planned to hit the sack early.

Ever been stuck axel deep in soft sand? Well, bright and early the next day (the day I was going to win all the trout trophies, that is) here comes a ghastly looking character staggering up to our home away from home, with a pleading look in his bloodshot eyes, just as I was about to take off, hairy little rod in hand. This guy, never having driven to Sand Beach, had taken a wrong fork of the road, barrelled about 50 feet before he spun in, and promptly went to pieces when his snappy little underslung sedan buried itself, with his expert help, hub deep in the soft sand. Our lonesome little camp, with my pickup parked safe and sound on hard ground, must'ave looked like the triple A division of Mexico to him and of course I obligingly drove him back to his rig to see what could be done to help him. Well, to cut this down to as few words as possible, we finally got him unglued after about 2 hours of shoveling, sweating and one helluva lot of swearing. After patting him tenderly on his cute

little spare tire as he hapily sped away. securely and firmly driving on a good solid stretch of road. I returned to my wife's ever lovin embrace and tender cold beer. After about a 15 minute rest I gaily startedout from camp again, visions of big snapping seatrout clouding my vision. I had made about a mile from camp, when sure as hell, there not 10 feet off the road where he had figured he and his wife (or girl friend) would get a better view of the Gulf was a Chevy coop buried to the fenders. I'll be honest. I tried to sneak past them, completely ignoring their weak pitiful cries of help, but that damned pickup of mine got 20 feet past them, braked to a complete stop, reversed itself and there I was, resignedly looking into 4 red rimmed eyes. 'Stuck???" I politely inquired as I disgussedly climbed from the cab, hooked my chain from their car to mine and started the whole messy ordeal over again. It was about 10:30 when we started to get his car that lousy little 10 feet back to firm footing. It was about 1 o'clock when we finally made it - even my toenails were perspiring when we got him out and I was hungry as hell to boot. I kissed he and his gal a fond farewell, cussed them under my hot buttered breath and backed all the way back to camp and had my snickering wife make me some lunch. After a couple of sandwiches and numerous beers, I brashly set forth again, stoopidly thinking that I could finally wet a line, even if I did have to hurry like hell to locate those big trout in time to get me qualified.

You won't believe this, but it is the honest to Gawds truth, and I have a whole campfull of witnesses to prove the following: This time I actually made a mile and a half from camp, before, lo and behold, walking right down the flat middle of the road toward me, waving his arms like a jackass, came the very same jackass that I had unstuck that very morning. This time he had screwed up on his way out. (I suspiciously think that Pat Ashby, the trout specialist, had employed this jerk to keep me tied up while he and his cute little Canadian wife caught the Derby winning trout). Anyway, by the time we got this G!!--! and his G--!! car out again it was too late for anything but making love to minute - it becomes an impossible rush.

my wife and, brother, I was much too pooped for that! I never got a jig wet that whole miserable day, and old Pat won his trophy with a 41/2 pound trout.

Fishing for seatrout during a Derby just always seems to bet me crossways like the Derby where I took Hammer and Lyle Underwood trouting with me for their very first time and the G!!-- louses snared a first and third prize trout while casting right smack dab beside me, and I never caught one measly trout - or the Derby when my wife and I accompanied Mary and Ernie Smith in Erns boat all th way to St. Georges Estuary to fish for trout, and I caught a skinny little old lonesome sick seatrout, deliberated on whether or not to throw him back, decided to keep him and found out later. after refueling at Rocky Point on our way back which made us late for weighin time, that that sickly little fish would've gathered me in a trophy and all kinds of prizes, as it happened to be the only trout caught by anyone that day.

So, fellow fishermen and fisherasses, don't feel too bad if misfortune louses up your Derby reputation - it's still one helluva lotta fun to just participate and mingle with the jolly bunch down there during Derby time - so have fun, catch lotsa fish and if you're way out there on some reef and hear a faint voice cursing this and that from the direction of the beach - don't be alarmed, it'll only be me having my usual run of luck, trout fishing.

## Official Rules

200

In participating in this derby all fishermen have an equal chance for treasured trophies and merchandise prizes. The proceeds are used to improve the facilities at Cholla Bay.

#### Classes of Fish and Prizes

The Derby will be classified into four groups for Rod and Reel Fishermen, which are as follows: GROUPER, PINTO, SEA BASS and SEA TROUT (including Yellowfin). Each group is an equal and trophies and prizes will be awarded accordingly.

The largest fish caught will be awarded a GRAND PRIZE TROPHY. The largest fish caught in each class will be awarded a FIRST PRIZE TROPHY unless it wins the Grand Prize Trophy. There will also be prizes for first, second and third place fish in each class each day.

Additional prizes will be presented as follows: largest fish if other than type classed, largest halibut, odd ball catch (at the discretion of the judges), many drawing prizes, using daily ticket stubs, and of course the JACKPOT DRAWING with the money taken in being divided as follows: 1st prize 40%, 2nd prize 20% 3rd prize 10%.

There will also be a team award for rod and reel fishermen — this will be available to those who wish to enter. It will be won by the crew that averages the greatest number of fish in pounds per person in the crew. Each fish must be one of the four classes to be counted. The largest single day's catch for both days will win the award (a prize for each crew member. A separate entry ticket wil be required for each day a crew wishes to enter. (\$1.00 per crew.)

#### Rules

- 1. Boats must check in and out at the Cholla Bay Boat Landing.
- Each Contestant OVER 14 years of age must purchase a derby ticket for each day fished, before leaving boat landing, and EACH party in boat must present Derby ticket at time entry is officially weighed.
- Children 14 years of age and younger will be eligible if all other members of crew have valid ticket.
- Separate tickets will be required for Friday and Saturday, and fish caught either day will be eligible for Grand Prize. (See team award rules in above section.)
- All fish must be taken on hook and line.
- A ticket holder must enter only fish caught personally.
- 7. Hours of the derby will be: Friday, Daylight until 7:00 P.M.; Saturday, Daylight until 6:00 P.M.
- 8. Fish must be checked in by closing time each day.
- Distribution of awards will be made at the Fish Fry.
- Winners need not be present, except for Drawing Prizes.
- 11. Sharks, rays, angel fish and other trash fish are excluded and decision of judges is final. Judging of largest fish will be by weight.
- 12. The decision of the judges shall be



#### Taxes..Taxes..Taxes

Let's stop them before they start.

Thanks to our Tucson Chapter, members are alerted to do something about a suggested Arizona tax on boats. The letter below should be used as a guide and your letter addressed to your Senator and House Representative in the Arizona Legislature.

You can do something about taxes . . . and here is how. Write your letter today! Dear Sir:

I own a boat and am very much concerned about a "rumor" recently heard to the effect that some persons are advocating the singling out of the owners of boats for the imposition of a "boat rax."

I want you to know that such a tax on boats, in my opinion, would be grossly unfair, discriminatory and, in the long run, would deprive the state of more tax money than it would gain. I have not yet heard of any one "suggesting" a tax on a golfer's expensive clubs, a photographer's elaborate cameras or a hunter's many rifles and firearms. Why pick on the recreational tool of the boating enthusiast?

The boat owner uses gasoline in his boat and pays a state and federal gasoline tax on each gallon although the gasoline is not used on the highway. This fraternity already contributes to the public benefit large sums in the form of this tax and, according to the motor vehicle division, but a nominal amount is ever claimed for refund. Boat trailers are now being licensed and taxed and boats already pay a registration fee. So, taxwise, this recreational activity is now being sufficiently discriminated against.

Most of the boats involved are small and are owned by the average citizen of the state who already is saddled with more taxes than he can pay. A boat is not a necessity and many people who own boats would not have them if a yearly "tax" was imposed on ownership — thereby depriving the state not only of the economy derived from sales activity but the taxes resulting from purchase and use of boats. Undoubtedly, more money would be lost from other taxes than would be gained by a tax on boats.

"When taxes are fair, we will pay our share," but until then we will protest to the fullest extent of our faculties.
