MEXICO MAY CLAIM GULF OF CALIFORNIA

MEXICO CITY (UPI) — A favorite sports and commercial fishing area for many residents of the U.S. Southwest — the Gulf of California — would be expressly declared Mexican territory under a bill introduced in Mexico's Congress this wek.

The measure was offered by deputies (congressmen) of the opposition political party, Party of Nacional Action (PAN) with a preamble stating: "This amendment does not create a new right, but expresses it concretely in a constitutional provision."

The 650-mile-long gulf, ranging in width from 75 to 150 miles, is bounded entirely by Mexican territory: Baja California and Baja California, Southern Territory, on the west and the

states of Sonora and Sinaloa on the east. One of its northern coastal points, Punto Penasco, is only about 70 miles by highway from the Mexico-U.S. border.

The gulf, which opens into the Pacific Ocean at its southern end, contains more than a dozen islands, and has for many years been frequented by U.S. sportsmen and by commercial fishermen from various countries.

Mexican fishing interests have for some time been urging the government to take action about establishing a more direct control over operations in these waters.

Foreign fishermen contend that beyond the claimed 12-mile limit for



Cholla Bay Sportsman's Club Tucson Chapter February 8, 1966

February meeting was called to order by President Chris Tatum. Minutes of January were read and approved. Gerry Erny read the Treasurer's report, approved as read. Mark Morgan talked about the rent situation at the bay. Mark wants as many as possible to go to the bay with him to talk to Mr. Brown, A number of property owners volunteered to go, a date to be set by Mark Morgan.

Chris appointed Wally Robinson, our Vice President, as Chairman of our Memorial Day Derby. Mr. Justin, State Representative of Arizona was special guest to talk about the new boat tax we are to start paying this year. All personal property in Arizona is taxable. Most boats in the state are 16 feet and under. Mr. Justin is working on this tax law to make it more fair. Suggestions to this were:

- 1. Change the registration to \$1.00 per year.
- 2. Charge 25 cents per foot on each boat, boats over 26 feet to be 50 cents per foot.
- 3. Should get boats out of Highway Division and in a Watercraft Division.

We feel that the tax is not necessary on boats and next they will tax guns, campers, bowling, golfing and other sports. According to law all boats have to be registered in the United States.

Each boat owner should send a letter to his Rep. in Phoenix. We could send a delegation from the clubs to meet at lunch with the Representatives in Phoenix. Mr. Justin is to write up an ASR to remove the boat tax. Call the Women League of Voters to get the name of your Rep. This was the first group Mr. Justin had talked to and he was overwhelmed with the fine group of 110 people that were present.

The officers of the club are to meet with Mr. Bade, the tax assessor, or the Board of Supervisors to talk about the tax on boats. We were very pleased with the interest Mr. Justin showed.

Mr. Ellis and Mr. Vlassis of Phoenix gave a talk on rods and reels, what kind to use and where. Mr. Les Stewart of Tucson Wild Life gave a talk on their club and how we could work together on this. Jack Ellis Sporting Goods gave two door prizes, dandy jack knives, won by Clyde Fox and Bill Sulfin, visitors to our meeting.

The meeting closed with coffee and cookies.

LOWER UNITS

"Hi Bill," Bill looked up as Bob walked in the shop. Hi Bob, How's things? Bill laid down the tools he had in his hand and picked up the cup of coffee, "Phuf, cold, darn it. How can I help vou. Bob?"

"Well every time I put my outboard in gear and put a load on her she almost jumps on the transom." Bill stood looking at the cold coffee and said without looking up, "For one thing you need a new clutch dog." Bob came unwound, "WHAT! Bill, you just put a clutch dog in that engine." "Yah, I know," Bill said, "and I also told you, if you didn't stop nursing the thing into gear, I'd just keep putting in clutch dogs. When you wanna' bring it in?" "It's outside," as Bob walked out the shop door talking to himself.

Bill's right, the outboard was made to put in gear as if you were mad at it, do this and your clutch dog will lead a long and happy life.

On the small engines, clutch dogs will last years, but on the larger engines the linkage should be checked for wear. Worn linkage can cause the clutch dog adjustment to change and the result is an engine jumping out of gear under load.

If the control cable adjustment linkage adjustment is right, at the time of installation and you get a little mad at your shift lever when you shift, you should have a healthy clutch dog for a long time.

One of the fallacies of the lower unit

is the leaking lower unit. Many a lower unit has been rebuilt only because it was doing the job it was designed to do, bleed off the extra oil and gas that's not burned by the engine. The lower unit has a small drain hole in it for this purpose. So if your lower unit has an oily look, be sure it isn't engine oil and gas. Any experienced nut-buster can tell the difference.

You would think that if water could get in, gear grease would get out, so if you find water in the old gear box, when you change gear grease and yet there is no sign of grease leaking out, it is a 50 to 1 chance you have a bad seal under the water pump. Go see your favorite outboard shop.

It's an easy chore to check for water in the lower unit. Remove the lower drain plug only. If there is any water it will be there. If you change the grease and it has the look of death, you're getting watr, not much yet, but your getting it. Type C gear grease (the type you should use in any OMC engine) is designed to absorb 50% water and still lubricate.

Some of the boys use just any old No. 90 gear grease, could be disastrous, some grease and water won't mix and under agitation cause gas, and you could loosen the seals in the lower unit.

I've had engines come into the shop and I almost flip when I see the prop. I do a 30 to 40-dollar tune-up on an engine and then have to put on a prop so out of pitch, it would shake the teeth out of a tiger shark. Think what it does do the shaft and seals of the lower unit. Have the prop checked when the engine is tuned up and take the advice of your mechanic, have the prop replaced or repaired if it needs it.

Now, some of the Do's and Don'ts of the lower unit -

DO check it for grease often, every two or three times of use.

DO have the linkage and adjustments checked at tune-up time.

DON'T use just any old gear grease. Only manufacturer's specifications.

DON'T ease your engine into gear, slap it in.

DON'T run a bad prop on your

- 11) Small box baking soda (used externally for burns and jellyfish stings; internally, 1 teas. to 1/2 pt. water in fish poisoning etc.)
- 12) Small flashlight make sure batteries and bulb are in working or-

Use it and be able to be located in case of emergency. We have a chain of command for search and rescue that reaches from Cholla Bay to Phoenix, via radio and telephone, the radio operator can call for help from Cholla direct to your Search and Rescue Chairman in Phoenix. Help us by completing your launch permit with grid and compass heading and BE SURE AND TURN YOUR PERMIT IN AT THE END OF THE DAY so that we will not be searching for a boat and crew that is safe in the sack.

territorial waters, the gulf is in the same category as the open sea.

However, the bill would put it entirely under Mexican control.

It states, "The nation is entitled to direct domain of all the natural recources of the Gulf of California, the continental shelf, the islands, and all the underwater areas."

The bill calls for "express statement that the Gulf of California is property of the nation and that the latter has control of exploitation of all natural resources. The gulf should be considered as "an interior sea or Mexican lake," the proposal says, and adds that "foreign vessels should respect as a closed sea the northern part of the Gulf of California." The southern portion of the gulf, which opens directly into the Pacific Ocean, presumably could be considered as open sea under the bill.
