

Method:

In a large baking dish, layer the ingredients in the order given; continue layering until all ingredients are used up. (Soups can be combined for warming. Top last layer of soup with reserved grated cheese. Bake at 350 degrees about 45 min. or until it begins to boil.



### FROM TUCSON By VERNA CONLISK

"Patience Is Still A Virtue"

Strange as it may seem (that is to all those people who are familiar with travel in and thru Mexico) some of the most unusual things can happen to someone making their first trip to that wonderful beckoning land of Mexico, or so it seemed to the people in this case.

The Davidson's, after being typical New Yorkers for 32 years, came West two years ago and have heard from many sources of the wonderful sights and fishing, etc., to be found down in Mexico. They even took some Spanish courses here in Tucson (being informed that it would be a good idea to have some use of the language if they were going without a Spanish speaking guide to accompany them). The Davidson's are people who like to explore the country they go to visit more or less by themselves to enjoy somewhat finding out things for themselves. This is of course a much more interesting way to travel. Especially when (if you are lost and ask for camiones (buses) instead of camarones (shrimp) when it is shrimp you are looking for. There are other mistakes in the language many people make, but as the Davidson's report, the Mexican people have a lot of patience.

The Davidson's have two children, ages 11 and 14, just the right age to enjoy a good Geography lesson in actual experience along with the joy of a vacation in a new Country. First things first. They all secured Visas at the border station and as Mr. Davidson was the registered owner of the car, the children's names were included on his visa. After this, merrily they drove along their way. They had rented a house in Patzcuaro well in advance. The plan was for Marilyn (Mrs.) and the children to stay in Mexico about six weeks, with Hank (Mr.) flying home after three weeks. They had spent three beautiful

weeks fishing, swimming, riding horseback, just resting or running about the country side looking into every conceivable new interest possible and time for Hank to fly home. Well!!! Somehow in crossing the border, their papers were snafued so Hank couldn't leave the country without the car and Marilyn (Mrs.) couldn't leave with it. Hank discarded the notion of swimming the Rio Grande when he learned they would confiscate the car anyway, if they caught Marilyn with it, so he suggested Marilyn sue him for divorce and impound the car (that Harvard Law School Education wasn't for nothing) but Marilyn was afraid he'd forget it was a joke, so they spent a week in Mexico City unsnafuing everything, against the most patient explanations of why it just couldn't be

portation in the world when you yourself are behind the wheel and everything works according to plan, but when you have only an hour and a half to get to Mexico City to see the right people to help you out of a situation like they had gotten themselves into and then something goes wrong with the car! In the meantime outside of Guadalajara the car hit a rock and locked the transmission into low gear: coming into Guaniuato the bearings were stripped, so you can see what a mess they were in. This brings out either your worse side or your best side and being in a Foreign Country you try to have patience but it is a real trial. Hank caught the bus and proceeded to Mexico City to keep his appointment with the Consulate, while Marilyn staved with the car and a mechanic to try to fix the car and join Hank. With Spanish the prevailing language and with not suffficient experience with the use of it under all circumstances let me tell you the Davidson's had quite a time trying to convey their meaning to the officials and to the mechanic that they were trying to get clearance to get Hank out of Mexico on a certain flight and had to get the privilege of the use of the car for Marilyn before he could go. Well, with great difficulty and much tolerance on everyone's part, the message finally got thru and Mr. Davidson finally got the correct papers and the family could stay another three weeks in Mexico; and believe me, it was really worth the effort as they took many side trips and now are a walking encyclopedia on Mexico Folk Lore and Mexican Customs.

Mrs. Davidson says she wants to go again next year. However, she wants to make sure these type emergencies don't arise again. One time "lucking out" is all one family can hope for. The people in Mexico were so pleasant and kind to them in their distress even when they wouldn't take No for an answer. And you know how impatient an American can get sometimes, but the Mexicans have the right idea. Patience is a virtue and believe me they have it.



### TUCSON SCUTTLEBUTT



MAY 11, 1965

The May meeting was called to order at 8:00 P.M. with Dean Fisher presiding due to the absences of the President and Vice-President.

Minutes of the April meeting were read and approved.

The treasurer's report was read and approved.

Dean Fisher described the trip to Prescott to Charter the newest Chapter of CBSC.

Many members voiced an interest in the shirts with the CBSC drawing silkscreened on the back. A list of members' names and shirt sizes was compiled and order was placed by long distance telephone to the Phoenix Club then in session, for twenty-nine assorted sizes.

Two new members, William and Thelma Morris, were introduced.

Presiding officer and Derby Co-Chairman, Dean Fisher, devoted most of the meeting to the mechanics of assigning Derby duties to the membership.

A motion was made to rent the projector and screen, with Chris Tatum as operator, to the Tucson Typographical Union for a fee of \$15. Motion carried.
