

Fishermen apparently just will ignore signs of approaching danger such as those that accompany a sudden squall. The date was Sunday, July 2nd - the hour about four in the afternoon. The water had been anything but smooth all day but not dangerous and several boats had gone out to try and fish. We ourselves went out but came back and were having a time playing around in the bay, trying out our new possession and racing with Wes Douglas in his "Poco Loco". Taking a final run out toward Pelican Point we became suddenly aware of an approaching wind storm, which hit suddenly and ferociously, sending clouds of sand and dust out onto the waters. We looked out at the boats at the Point and farther out and decided to run out and see if anyone was in trouble, we found most of them just churning around trolling, ignoring the already rough waters. We did persuade some of them to follow us in. Nearing the launching area, we put in a call to the Base Radio Station to tell them that we had

warned all boats to come in and that we were coming to shore. The Shahans were at their usual post, where they had been since early morning, keeping the radio open for calls from boats with radios. Again our radio blared forth with a request that we go to the end of the bay where there was a small boat with one motor that appeared to be in trouble. One boat was still merrily churning around and having a grand time trolling in the rough waters with waves tossing them about. We found it but saw that it already was turning around, the skipper realizing they could not make it, and we followed it back to see that it reached shore safely. One more trip to Pelican Point and we finally herded that last boat around and

catorial attempts. All this, of course, had me firmly convinced that I was a pretty wise cookie, as far as fishing was concerned.

You've all heard the old saying, about 'Pride goeth before a fall'? Or something like that, anyway, brethern and sistern, mine sure as helleth felleth, before that humid little old week was over.

By this stage of my career, I had successfully boated an even dozen sailfish with nary a hitch, had also taken numerous buddies into the mysteries of the wild Blue and covered them with glory, in the form of successfully gaffed Dolphin, Bonita Skipjack, or 100 pound sails. I was one of Lady Lucks chosen few, I was an expert.

Well, Jessie and I set out, this one particular day, in the Afrikan Queen to gather in a few goodies from the Blue water world. Along with our two conventional sailfish rigs, I, brave bull that I was, decided to show the local natives how a competent fisherman such as I, could thrash a 100 pound sail on a 15-lb. test spinning rig. Our bait box had a dozen sexy lookin little mullet and a few slimy bite-sized mackerel iced down.

After reaching the inky blue depths, I slowed the Queen to a crawl, and proceeded to rig up the spinning rod. I had done a good selling job on Jess, so that she was not going to fish till I had boated my first sail on the spin rig.

HA!

Picture if you can, an idiot trying to pull a boiled potato through the side of a cement block with the aid of a long rubberband attached to a piece of limp, wet spaghetti. An idiot trying that, would have had as much success as this idiot did, attempting the way I attempted.

My temper, nerves, coordination, and a half pint of Sauza Tequila, were completely shot by the time that miserable little excursion was over with. I had strikes galore, lost two teasers to hungry sails, but just couldn't, for the life of me, solidly set a hook, with that spinning rig. I was the most frusterated fisherman ever seen by the eyes of man. After I had fouled up the forth bait on a flubbup, it slowly dawned on me that I was doing something decidedly unsuccessful, and had better change my procedure damn quick. I had performed beautifully on those first four strikes, that is if I had been using a conventional rig - I had let the fish run on free spool (open bail) for a good 10 count, then gracefully and with threw the motor in gear and poured the coals to the queen, and then reared back repeatedly on my wet-spaghetti type rod. By following the above described procedures, I had boated, so far, a big bunch of nothing. Invariably, after each strike, behind the Queen would erupt a glorious purple silver, fighting mad sailfish, chagrined at having his chow pulled so rudely from his hungry maw. I would then proceed to crank in a thoroughly pulverized mish-mashy sad-looking piece of mullet, which I would remove from the faithless hook and cast disgustedly away.

From the fifth to the twelfth mullet, I staunchly decided to do something different, even if it was wrong. I craftily decided that if I would just give old man sail a 20 count, he would have time to completely swallow the bait, and inevitably, hook himself. This my friends, was very clever thinking. The only thing that messed up my murdereous plans, was the fact that on 15-lb. test line a deep running 100-lb. sailfish puts at least 20 lbs. of pressure on 15-lb. line, and the inevitable happened - boom, I would reel in less line than he had run out. This, by the process of elimination, left that spinning reel with only about 100 yds. of line left on the spool. By this time, I was down to my last mullet in our bait box. I was really getting exasperated by this time, and throwing caution to the winds, decided to try and set the hook on a 5 count, if one was silly enough to hit my last mullet bait.


