

This call, heard at the Bay hundreds of times each year, may be only to check the operations of a boat radio, but for many boaters and fisherman, it has been a life-saver.

The Cholla Bay Sportsmen's Club maintains a "check out" or "launching permit" facility at Cholla Bay and second in importance to the use of the "check out" forms, for safe boating, the Club has a marine radio for emergency communication with boats in the area.

The radio is licensed to the Club by the Mexican Government through the Tourist Department of Puerto Penasco and the State of Sonora. The Cholla Bay Sportsmen's Club gratefully acknowledges the unusual privilege of being allowed to maintain the "Ship to Shore" radio station at Bahia "La Choya". The licence indicates the station is for safety communications with tourists boats, Club members boats and Charter boats owned by citizens of Mexico.

A "watch" or listening schedule is maintained only when the lauching permits indicate a boat equipped with radio is checked out and No checking out over the radio is permitted. The watch is on 2182KHz, the international calling and distress frequency. A second frequency, and the only other one, 2555KHz is for all messages after contact is made on 2182KHz.

The 2555KHz frequency is extremely important to all users of the station, in that is a "clear channel" assigned exclusively to Cholla Bay Radio.

The proper and best method of contacting the station, is to call on

2182KHz. Normally there will be at least a thirty second delay before the operator can answer due to the "warm up" time needed for the transmit section of the Club's radio. When calling, the station's name should be first and the name of the boat second. The words "Cholla Bay Radio" repeated at least two times followed by the boat's name and two calls spaced about fifteen seconds apart will be more understandable. The least number of words, that will get the facts to the operator, spoken slowly and clearly will save time and eliminate misunderstandings.

No "Radio Direction Finder" equipment is installed in the station, so the compass direction and distance information given to the operator, should be very carefully com-

puted when requesting aid.

It should be clear to everyone that the station is for emergency communications and the use of the radio and operator for any other reasons, should be held to the very minimum. Unless some danger to life and property is involved. The request for launching machines and other services should not be made to the Club's radio station.

The "range", of the radio station, is over 100 nautical miles and boats cruising to the Baja side of the Gulf of California or down the coast, can communicate, on a scheduled basis, (twice that distance on 2555KHz) the conditions of the crew and the

position of the boat.

Power for the radio, lights, beacon and beach control public address system is drawn from a twelve volt battery bank. Battery charging is done with a 500 watt, direct current generator, fueled with butane. The station's radio and power system is maintained by a licensed radio technician and the Club has made a considerable investment of money in the equipment and the building to house the facility.

FROM THE EDITOR'S DESK

As of this issue of the Chatter, the galley list is absolutely up to date. Please members, when you move, notify the Editor personally or by mail. In order for the Chatter to reach your homes before the general meeting especially the Tucson members. the press date for the Chatter will be the first week of every month. It seems to take more than 3 weeks for the whole process. I was told 1 week for set-up, 1 for printing and 1 for mailing. The mailing seems to be the problem, as the Chatters are sent on a bulk mailing permit. So, we'll see how this system works out.

As previously asked by other Editors, how about some articles from the members? The February issue was outstanding, for the reason along. I can take articles from printed matter, but that isn't what we want, is it? I can write articles about the Bay and the goings on every month, but that isn't what we want either. I need "stuff" on everything and anything, that's of interest to us Cholla Bay goers. Sure wish those fellows on the boat "Oso" would tell us how they do it, never saw anything like it. If they went out and came back skunked. don't think some of us would ever go fishing again. Just wouldn't be any fish out there in the deep.

So, come on everybody, give this editor some breaks.

Because the publisher of the Chatter demanded articles earlier in order to meet our deadline, I will not be able to give you the results of discussion at our meetings in the current issues. And facts that you should know will be a month late.

I have a doctor who, when you you are sick, gives you medicine that tastes so good that you are glad you are sick.

I guess, at this time, most of you are interested in your Income Taxes so here are a few facts that may help you.

If you are inclined to be a tiger or a wolf, fox or lamb, when its tax paying time you always end up being a goat.

Some nontaxable income. Unemployment compensation, workmen's compensation sickness or disability payments, social security or your own accident insurance policy payments. As much as \$20 a day or \$100 a week of earnings you got while out sick may be duductible (use special Form 2440). The first 30 days you are off from work are not deductible.

Business Travel. (Use Form 2106) Out of town transportation for which you were not fully reimbursed by your employer. Food, lodg-Eight ing, etc. Also, are deductible. The cost of getting from one place of work to another the same day. You cannot deduct commuting costs from home to your regular place of work.

Social Security Refund. Don't forget, if you changed jobs during the year, the social security deducted from your pay over \$374.40 is refundable to you.

Congress is smart. They put a big tax on liquor and then raise other taxes so high you are driven to drink.

If you work for yourself here are some items often missed. Dues to a professional society, dues to business associations and the Chamber of Commerce, Xmas presents and most other small gifts to promote business. (There is a \$25 limit on the amount you can give to any one person in a year.) Professional library. Figure the entire value and deprediate. Union dues, small tools, periodicals, uniforms not adaptable to street wear.

The man who says it doesn't cost anything to laugh apparently hasn't heard of the amusement tax.

If your child is under 19 or a student you may claim him no matter how much he earned as long as you furnished over half of his support. Generally, parents or other relatives who earn less than \$265, not counting Social Security or non taxable insurance proceeds are dependents if you provided half of their support.

You get an extra \$625 exemption of you or your wife are over 65 and another \$625 if you are blind (or wife) Blind means that you have no better than 20/20 vision in your better eye.

"IF YOU CAN'T CATCH 'EM FROM YOUR BOAT, GO DOWN WHERE THEY ARE"

To every sport fisherman, there is always the challenge of outsmarting his quarry by guessing which lure or bait the sought after fish will desire enough to make that fish an enjoyable meal or trophy to photograph. Have you ever contemplated what it would be like trying to outsmart or outmaneuver that fish in his own enviornment, so that you could bring him in on the end of a spear? Frightening thought, you say? Too much challenge? Or, maybe you can't swim that well?

I am referring, of course, to the sport of skin diving or SCUBA diving, as means of acquiring an enjoyable meal or trophy specimen. However, I would not limit the sport to that activity along. It is, as the title implies, one of the most rewarding sports one can partake of and contribute, to, while enjoying the sun sea and people of the Gulf of California area.

There is a fantastically beautiful world under the sea's surface for you to discover. A world so varied and so colorful that even underwater photos do not do it justice. Hours upon hours can be spent investigating (and collecting) the sea life that lies within easy skin-diving dept of that underworld world? It isn't crowded—and it's serenly quiet Two hours spent diving on any given weekend can be a most effective cure of whatever it is you use as an excuse to "get away from it all".

I mentioned SCUBA diving earleir. You've seen the Mike Nelson series on TV? Or read about the Aquanauts? Well, those fellows use



Scuba Gear. Self Contained Underwater Breathing Apparatus. Whereas the skin diver is limited to his time underwater time by carrying a tank underwater by his own lung capacity, the Scuba diver increases his underwater time by carrying a tank of compressed air on his back and a regulator through which he breathes that air. Now he is able to stay underwater longer and, of course, can go deeper than the conventional skindiver. Sport Scuba diving is generally limited to a dept of 125 feet.

Why should you want to stay underwater for thirty minutes? To make like a fish, of course! To get a better, longer more thorough look at the world you've never seen, and never will see without being there. To bring home a beautiful conch shell that you found! To stalk and spear 3-60 pound sea bass for your dinner table! To watch the beautiful colored fish watching you!. To wonder. To learn, To do what very few people in the world will do.

There are many favorite diving sports in the Gulf of California. Among them are: Rocky Point, Lobos Liberated, Tiburon, Kino Bay, San Autustine, San Pedro Island, San Carlos - Guaymas area, and if you have the means, any of several locations on the Baja Coast. Depending on the season, you can spear grouper, pinto, red snapper, yellowtail, and if you are really adventurous-

an eel.



THE FUEL SYSTEM

The vapors generated from ½ pint of gasoline are equivalent to the explosive power of 5 pounds of dynamite. Multiply that a few times and you can see what the result can be if you spill or gasoline leaks into the bilge of your boat.

If you have installed or are going to install permanent tanks in your rigs it should be done right.

No tank should be installed directly on the deck, that is the best way to rust it out, also it's hard on your deck, tanks should be mounted 1 to

2 inches off the deck, so water and dirt will not lay under the tank. The suction line should come out the top with a drain in the bottom to drain off water or oil accumulation, if you have outboards.

Filters should be installed between the tank and engine especially if you use Mexican gas—the type filter used on automobiles work real good, for both inboard and outboards. The tank should be vented and a deck type filler installed for filling the tank.

(No tank large or small should be filled from in the boat.) That is the best way to fill your boat with fuel, vapors and for you to go into orbit.

The tanks and filler pipe must be grounded to the water, there are grounding plates that are made for this purpose.

The damages from explosion by gasoline vapors are not limited to the inboard boat, I've talked to boaters with small ski boats and even the sailor with 17 and 18 foot outboard boat, and some have the idea that unless you have a 24 footer and an inboard there is no danger from gasoline vapors. it, fuel vapors are heavier than air and will settle to the lowest part of your boat and lay there until exposed to the open air or a spark.

Any compartment that has gasoline tanks in them should be aired before you go poking around in them.


With the outboard there isn't too much damage of engine spark igniting gas vapor. Your outboard has built in anti-explosion safeguards, but you as the boater don't have, so it's you that can cause the spark, so be careful. Air that compartment and that inboard won't forgive you often for not turning on the flower or airing compartment before starting your engine.

The coast guard says you have to ventilate the tank and engine compartment by forced air (air scoops) and/or blower and they mean it, I believe some have found that out the hard way.

The air scoops ventilate the bilge and engine compartments while underway and the blower for cold starts. It should be run five minutes before starting your engine.

Some of the boys are using blowers out of carheater, they are good blowers and will move a lot of air, but they are not vapor proof, they could put you on the bottom, If you see this type of blower do not mount in the bilge or compartment.

The surest way to make sure your bilge or compartment is free of vapor is a fume detector. There are many on the market.

FACTS

Can fish make sounds? How well do they see? Can they distinguish one color from another? Do they feel pain?

These and other questions have fascinated fisherman since primitive man first wet a line. The answers to some of the angler's usual questions are purely academic, while others give clues to successful fishing.

Here are a few facts on which most scientists agree:

Can a fish feel pain when he is hooked? To some extent, but the sensation of pain is probably not as keen as it is in mammals. It's unlikely that a hooked fish would pull so hard on a fishing line if such action greatly increased its pain.

Can a fish make sounds? Some make a grunting noise by forcing air from the air bladder through their mouths. Others gnash their teeth. Fishermen in Malaya put their heads in the water and distinguish the direction and types of fish making underwater sounds (or so they claim).

How do fish manage to support themselves at various depths so effortlessly? Submerged, fish weigh little or nothing, because the total volume of water they occupy weighs about the same as they do. Bottom dwelling species are heavier than water.

How well does a fish see? Most biplogists agree that fish see clearly at close range but that their distant view is limited. Fish can tell one color from another. And they have preferences. Bass, for instance, seem to favor red or yellow lures.


