So, watch for the increase when you pay your insurance next time, but be legally covered through your Club!



#### TAGGING SHARKS


We were visited at the Chova Bay Oceanographic Station recently by Mr. C. I. Gause of Tucson. Mr. Gause was at our favorite fishin' hole looking for sharks so he could tag them for the American Institute of Biological Sciences Shark Panel. This is part of a worldwide program to study the comings and goings, etc. of these marauders of the sea.

He had read of the program and wrote to Dr. Stewart Springer at Stanford University, Palo Alto, California to volunteer his services. He had received a kit consisting of metal tags, special pliers to apply them with, and forms to fill out. Before he received the kit he was always catching sharks but since then, he hasn't caught a single shark, and so he was heading out to try his luck at Cholla.

I told him of Johnnie Newcomb's shark and he immediately wanted to know where this all happened. Turned out the desire for directions was so he could avoid the area since he was going out in a 12 foot car topper boat. He promised to send me more details about the shark tagging program since I thought that some of the Club fishermen might be interested in participating in such a program.

So far, however, it hasn't arrived and I put this meager information in the Chatter primarily so that, if anyone catches a shark with a 1/4" x 1" stainless steel tag attached to its fin that they note its number and send the information to the address on the tag, to Mr. Gause at 8868 E. Bluefield St., Tucson, or to me.

#### Documentation of Shark Attacks

At the New Orleans Shark symposium in April 1958, it was decided that shark attacks on man should be documented on a worldwide basis, and that the Smithsonian Institution was a logical place for maintaining such a file. Among 1004 shark attacks reported at that time it was only possible to obtain a positive identification in forty.

Dr. Leonard P. Schultz of the Smithsonian Institute, therefore urges that, whenever possible, at least several teeth be saved from sharks involved in attacks on man and on boats. Shark teeth are sometimes found embedded in wounds and are frequently found in the wood of boats. The teeth should be collected and forwarded by mail to the Smithsonian Institution along with one of the completed reporting forms.

Photographs should be sent also, if available. All such information and specimens would then become a part of the documentation for shark attack studies. A copy of the form is reproduced here to show the type of information desired.

#### Shark Attacks on Boats

Dr. Leonard Schultz of the Smithsonian Institution in Washington, D. C. summarized in the March 1967 issue of Chesapeake Science instances of boat attacks by sharks in the Smithsonian files. This includes those instances where an unprovoked or provoked shark deliberately made contact with a boat, such as canoes, dinghies, sailboats, rowboats, outboard motor boats, motor launches, lifecraft and the equipment being used in their operation.

Provoked attacks are usually the result of catching a shark on a line, or in a net, or spearing it. A few attacks were caused by pursuing the shark with a motor boat after which it turned and attacked.



The most violent attacks on boats have been made by white, make, and tiger sharks. For example, one 15 foot white shark took a snapper off a line tied to a boat, then charged and bit through planks on the hull leaving a tooth embedded in the wood. It was repelled by starting the motor. A mako shark made a dozen passes at the propeller of an 18-HP-outboard motor boat until a hard blow of an oar repelled it, whereas in another attack a 14-foot shark left 3/4 inch long dents in the propeller blade. A 15-foot white shark hauled aboard lunged with such ferocity that its tail shattered thick timber planks and moved the wheelhouse half an inch off its base. An unprovoked 6-foot make attracked to bright red plastic lettering on the stern of a launch bit into the lettering on four attacks before it was gaffed and killed. This shark also left teeth embedded in the wood.

Usually an attack consists of only one or two strikes. However, one 14-foot shark continued to attack for four hours every time the occupant showed his head above the gunwale.



Sharks have jumped into boats on several occasions. One went through the windshield of a small inboard-motor boat. They have been stunned by rushing boats violently. Others have leaped completely over a boat in an attempted attack.




I am probably the biggest coward in existence wherever sharks are concerned. I have witnessed at very close range what terrible damage these saw-toothed seavengers can do when aroused.

They have ruined many hooked gamefish, which would have undoubtedly made the record books, just by ripping a chunk of flesh off the fighting fish which automatically disqualified it for a record.

I have had 40 pound tuna off Eniwetok Island in the Pacific engulfed in one bite, leaving only the head for me to reel in. I had the same thing happen when fighting 30 to 40 pound African Pompano, and a herd of these ugly brutes moved in to slaughter the hooked fish.

I even had one 7' white tip shark take a white bass flat away from me that I had speared. I was in about 10 feet of clear water between a couple of coral heads when I speared the Bass. He dropped to the sandy bottom in slow circles with my dinky little spear stuck through him. I surfaced, drew a big fat supply of air, then headed to the bottom to retrieve the fish and my spear. I reached the fish just about the same time the white tip did. I graciously allowed him to help himself while I immediately reversed directions and broke all swimming speed records

in the process. He had his choice of tidbits and I was quite relieved at his decision.

In the Cholla Bay area, I've hooked hammerheads much too big to try and get aboard. I've hooked these flat headed monsters not over 1/2 mile offshore from sandy beach.

Ihave had little 3 foot sand sharks leisurely chaw off sea trout and pompano I had strung upon a stringer and tied to my waist, when wading waist deep while spincasting. This makes me a trifle nervous.

Also spincasting between the 2 estuaries, I've had a whole school of four foot and five foot sharks move in and take every dang trout I would hook. I would move on down the beach a mile or two and damned if these sharp nosed rascals wouldn't find me again. This can be quite discouraging.

The only time I like a shark is when I've either drug him up on the beach after a good strong fight, or held him at gaff length and with a sharp knife, ripped his guts out... then, and only then do I feel a smidgeon of affection for any shark. All other times, I hate sharks with a white hot hate!

#### Rules - Don't Be Shark Bait

- Do not wade in water with stringer hanging from waist or, if you do, do not place injured fish which is bleeding on the stringer.
- 2. Do not go into water if you have a cut which is bleeding.
- Avoid wearing shiny objects such as belt buckle, metal stringer, etc., which will flash and attract attention.
- Stay out ofwater when murky. Most reported shark attacks on swimmers have taken place in murky water conditions.
- 5. If you see a shark, do not panic and rush for shore. Slowly and carefully back out keeping eyes on shark at all times. Do not make any sudden moves.
- Wear good grade of polaroid glasses. Excellent for spotting underwater objects as well.

All to be said about sharks is not bad, however. They do furnish excellent sport in fishing for them from the surf. At times they will readily take lures, but the best way to fish for them is with a piece of cut bait, preferably mackerel fillet.


