


From the Editor's Desk

In the June issue I commented on some new lures I was planning to try which have been most effective for sea trout on the Gulf of Mexico and Eastern Seaboard.

One I was especially anxious to test was a jib head-rubber worm combination manufactured by the Creme Lure Company of Tyler, Texas.

This lure which goes by the catchy name of "Specs-A-Go-Go," was written up in a national sports magazine last year as the hottest lure for speckled sea trout (Specs) ever to hit the Texas Gulf Coast. Fishermen were bringing in fantastic catches of sea trout and found it equally effective on red drum and many other species of ocean gamefish.

The worm is about 1/2 the length of the conventional fresh water version and is firmly attached to the jig head with a rubber retainer ring. It comes packaged with an extra worm which is easily attached to the jig head in case the original is mutilated. A variety of colors are available, but the most popular are a yel-

low body with black spots and a solid light red.

Due to illness in the family, I wasn't able to get down to the Bay until last month. Bill Valentine had warned me that surf fishing had fallen off sharply due to the heavy gill netting, but being the eternal optimist, I was hoping it wouldn't be as bad as described.

As we headed down to the Estuary Saturday morning, I was filled with that old anticipation. The surf was perfect and we could see balls of bait fish all along the shoreline. As we bailed out to fling a lure behind a big school of bait, up roared a gill netter and with a banging of oars they soon had circled the big school of trout.

Within minutes another gill netter rushed to the same area and we hung our rods back up without making a cast. This same procedure was repeated time and again during the next few hours until we finally gave up in disgust.

Sunday morning we got out before daylight hoping the gill netters were late sleepers. My brother Jerry did manage to hook and land a nice 15-pound yellowfin before the first netter boat came plowing along right at sunup. Another was right behind it.

We decided to give it one more try late Sunday afternoon hoping the netters might lay off at least part of the day. As we pulled out on the beach, there wasn't a boat in sight and we could see fish working right on the shoreline.

Jerry quickly grabbed his rod and was hooked into a trout the first cast. Resisting the impulse to snap on the

I knew the trout were there - now was the time to see if they went for worms like their fresh water cousins. I cast right behind Jerry's hooked trout. The worm no sconer hit the water when bang! I had one on! This was a hungry school and for the next hour or so, we had a ball.

I worked the worm with a slow deep jigging retrieve just like I would for fresh water bass. Nearly every cast produced a savage strike and when one got off, it was hit almost immediately by another.

By the time the school moved out, I had all the proof needed that Creme has come up with a sure-fire sea trout killer.

I left Cholla Bay with mixed emotions. The "Spec-A-Go-Go" had proved to be every bit as effective in the Gulf of California as the Texas Gulf Coast and would now be a stock item in my tackle box. On the other hand, I was depressed to think that surf fishing may soon be a thing of the past in the Rocky Point area if something isn't done to control the excessive gill netting.

Shrimp Thermidor

3/4 lb. cooked, peeled, cleaned shrimp

1 can (4 oz.) mushroom stems and pieces--drained

1/4 cup butter or other fat, melted 1/4 cup flour

1 teaspoon Worcestershire sauce

1/2 teaspoon mustard

1/4 teaspoon salt

Dash cayenne pepper

2 cups milk

1/2 cup pitted ripe olives, sliced crosswise

Grated Parmesan cheese Paprika

If large shrimp are used, cut in pieces. Fry mushrooms in butter for five minutes. Blend in flour and seasonings. Add milk gradually and cook until thick, stirring constantly. Add olives and shrimp. Place in 6 well-greased individual shells or 5-oz. custard cups. Sprinkle with cheese and paprika. Bake in a hot oven, 400° F., for 10 to 15 minutes or until cheese browns. Serves 6.

Welcome to Cholla Bay, Mexico. You are about to enter some of the most pleasurable and at times some of the most hazardous waters.

You are required to file a float plan. It is imperative to be as exact as possible. You as skipper are responsible for your craft and its passengers.

The Cholla Bay Club maintains and provides the Radio Station and a top notch operator, who is in contact with the Captain of the Port. This is the Marine law of the area. Do not forget you are in Mexico.

The Search & Rescue Unit of the Club is a volunteer select group which is operated on your donations subsidized by the Club. Its primary purpose is safety and your well-being.

These men are your insurance and a member is notified if you are not back near your designated hour of return. A search is then organized and a set procedure is followed according to conditions. This can involve up to 10 boats and/or 10 jeeps

and sand buggies. It can involve the use of an airplane. Considerable manpower and equipment are involved. Someone has paid for your safety so if you are the object of a search do the same for the next fellow.

Be sure to have extra water, food, clothes and proper safety equipment in good condition for your own well being.

Remember, be exact, be careful, be thoughtful.

Have fun and good fishing.

Of all the reasons I can think of that would make a grown man cry, one would be the new skipper of his first new boat and his first trip to the lake with all his friends, and have a boat that wouldn't perform the way he was told it would.

No speed, it failed to pull water skiers or carry a normal loadwithout doing tail stands. Well I guess he would have a right to cry, but 90 percent of the time it isn't the boat or the engine at fault, his outfit just doesn't have the right prop. The selection of the right propeller is the most critical factor in the good performance of your boat. Having the right propeller on your rig permits your engine to turn the right RPM's and do the job you want it to do. But no one propeller will do all the jobs you ask your boat to do and do it correctly. I've have many people ask me what propeller comes with their engine? My stock answer is a standard propeller. I'll bet you can guess the next question they ask. And the answer to that one would take some time, but the short of it is manufacturer's selection of a propeller that will do the best job on the average boat, with an average load and

will let the engine run at its rated RPM's at full throttle. I can't for the life of me see where the average starts and stops. At the shop when we have a new outfit going out, by looking at the rig and talking to the new skipper we can come pretty close to giving the right prop. We may get off with only one change. You really can't come up with a real good propeller selection or change your prop to do various jobs without knowing what RPM's your engine is turning and that takes a tachometer. Most all I/O's come with tachometers as standard equipment. If your rig doesn't have one, it is a good investment. Your tachometer gives you a constant check on your engine performance and can help you select the right propeller for the job that you ask your boat to do whether that is fishing at the Bay or water-skiing on the lakes.

All engines are rated for so many HP at so many RPM's. The faster it runs, the more H.P. it puts out up to a point which is called the peak. Most all engines are rated at or near this point. Your 2 cycle outboards were designed to operate at full throttle or at the rated RPM's. It's at this speed that it gives the best all around performance, plug life, fuel economy and engine life.

If you're trying to find the right propeller for your boat and you have a tachometer, do it at full throttle with the average load you carry in your boat and follow the rated horsepower of your engine you'll have the right propeller for the full range of your engine.

Remember . . . If your RPM's are too high add pitch.

If your RPM's are too low, reduce pitch . . . See you at the BAY . . .

CHOLLA BAY CABIN
