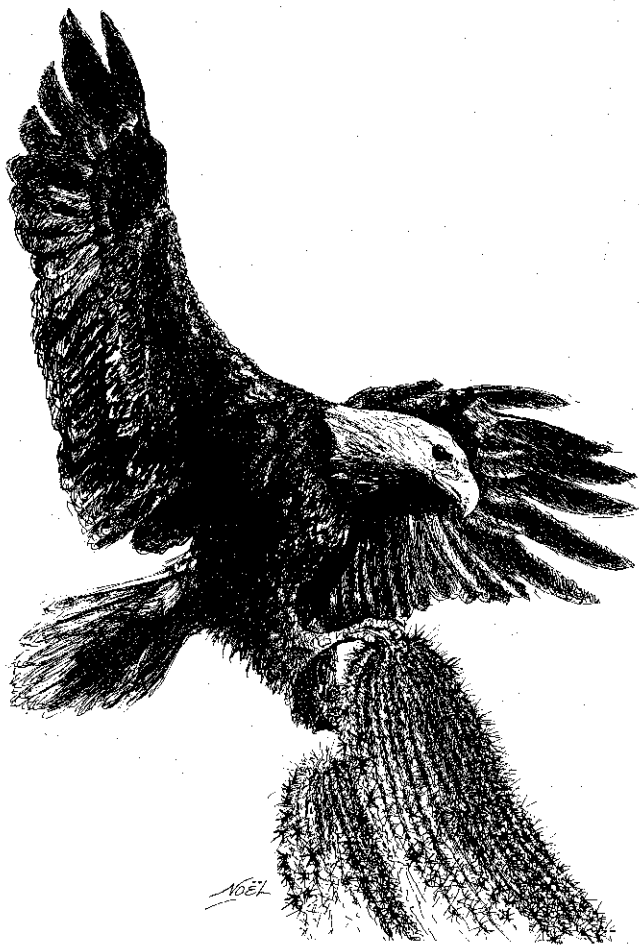

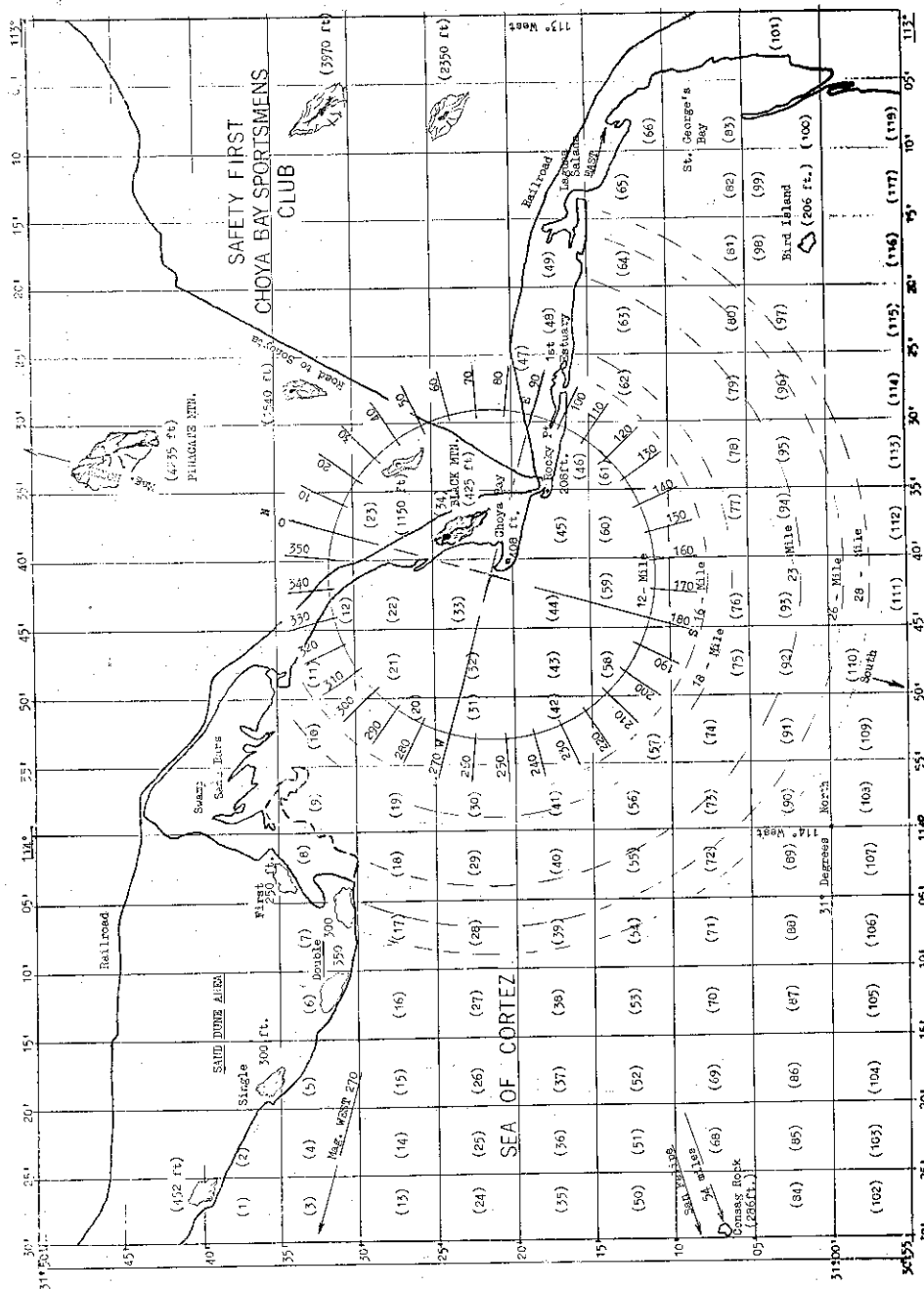

## SEARCH & RESCUE

If you are not familiar with the grid map on the opposite page, you will want to get a copy from the Radio Shack for a dollar.

Numbered grids are for ease in location. Each section is 5 miles square. All measurements on the chart are approximate.

Horizon sighting is approximately 7.7 miles, in calm seas and at an eye level of 6 feet above the water.

Compass degrees are magnetic. True North is 13° westerly.

Be sure you sign OUT and IN. These are dangerous waters! Do not take chances. Properly equip your boat. Observe RADIO courtesy and use the BUDDY BOAT system, it is successful!

If you use this information properly on your launching slip. S & R will have an area 5 miles square in which to start looking for you. Present wind and tide conditions would of course have to be taken into consideration. Here again, we emphasize the importance of putting down an anchor immediately when you have a problem. Otherwise, you will not be where you think you are.

**! IMPORTANT !**

Sr. Augustine, Cholla Policeman, has advised that you should be very careful about speeding and littering from now on. You will be stopped and fined. You'll want to warn your friends and neighbors.

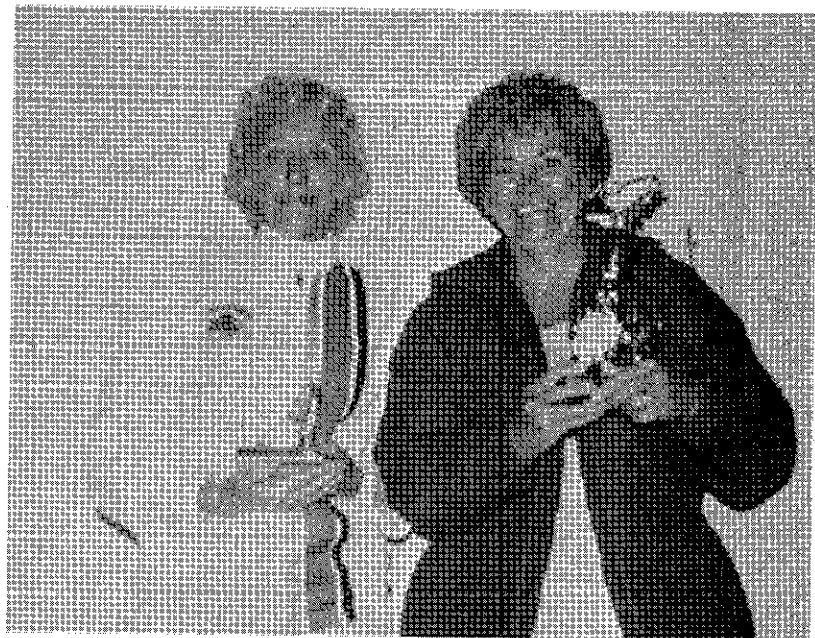

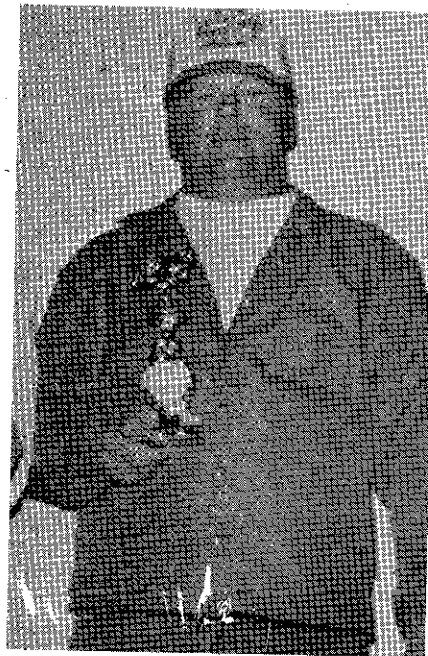

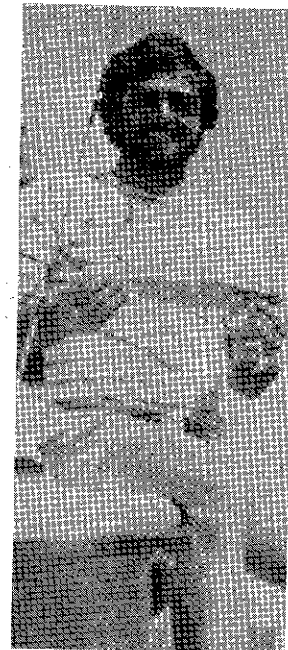

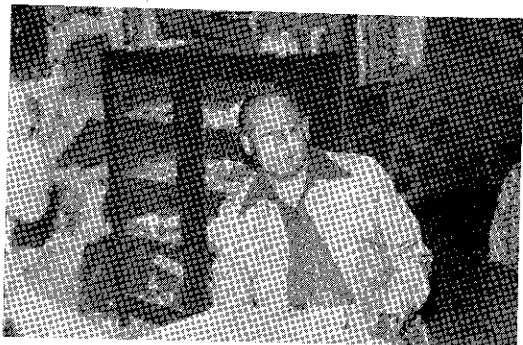

The JULY MEETING HAS BEEN CANCELLED by vote of those members in attendance. However, the August 13th meeting will be held at the regular time and place. Mark your calendar now so you won't forget. Also the BEACH COMBER'S DANCE will be held August 16th at the Western Saddle Club, 2000 E. Myrtle from 8 PM to 1 AM. Tickets are only \$5.00 per couple.

There will soon be a petition circulated for signatures of all interested visitors to the Bay whether you are a club member or not, for the purpose of getting the border officials to keep the border open through the night on Sundays. Perhaps this would put a stop to the traffic mess many of us got into Memorial weekend.

George Rodgers, Christmas Party Chairman, asked for donations for the party and especially for items which can be raffled at the meetings for the Cholla Bay Christmas Fund. Dick Harmon is a most generous person. He gave George a sand buggy, then asked if he would rather have the money. The answer being yes, Dick sold it for \$200.00 and gave it to George for the Fund. I don't think George even had time to give it a test drive. Thank you very much Dick.

Our publisher, Ken Kasten, who has been so kind as to print the CHATTER each month, free of charge, was hospitalized with a stroke on Thursday after the fish fry. He is now at home and coming along very well. We are hoping he will soon be as good as new. We surely will miss you Ken, until you are back to your same old self again.

Verlene Barber, Sick Bay, was under the weather, so will just wish her and those of you who have been ill, a speedy recovery.

Don Barber reminded all of us to stay off of channel 3 for private conversations. You will be asked to get off, especially if an emergency exists.

There were several emergencies over the holiday weekend and I have asked Ruth Ann Woodward to give us the following report of her first hard experience with one of them:

Any of you who were at the Bay over the Memorial weekend, most certainly saw or at least heard about the Pemex helicopter landing on the beach in Cholla. We will take this opportunity to set the rumors straight.

A young man was injured in a motorcycle accident on Sandy Beach. The Blue Cross Ambulance people carefully moved him to their 1st aid station at the Motel in Cholla where thanks to Dr. Soto of Rocky Point, he was partially stabilized. It was evident that he needed advanced care as soon as possible and Augustine arranged for the Pemex copter to transport him to the Rocky Point airport where a flight from Phoenix was to pick him up.

After a considerable delay, it was obvious that a communication mix up on the Phoenix end meant that no plane was on the way. Blue Cross again responded, taking the patient from Rocky Point to the border where he was transferred to a KORD's ambulance, further stabilized at the Ajo hospital and returned to Phoenix. Better than 12 hours had gone by since the time of the accident.

He suffered a concussion, fractured shoulder and two fractured vertebra. He spent six days in the hospital and is now recuperating at home. He was lucky! Had he suffered serious internal injuries, he may not have been so lucky.

Two very important questions must be asked as a result of this incident: 1. Do you know what to do in a medical emergency? The Club 1st aid room is full of equipment. It is useless if you don't know how to use it. 2. What do we do in a similar situation when more immediate transportation is critical?

The response to the Paramedics Unlimited class in Phoenix was fantastic. Should there be sufficient interest, it can be repeated. The Mexicans were more than cooperative but we were caught without a plan of action resulting in considerable delay. In this case the patient was stable and as I said before, he was lucky. At this time positive plans are being made with various agencies to avoid further trial and error experiences. You will be kept posted.

Chuck gives Pete, their son, a lot of credit for keeping the EAGLE in top notch shape and ready for sea duty at all times.

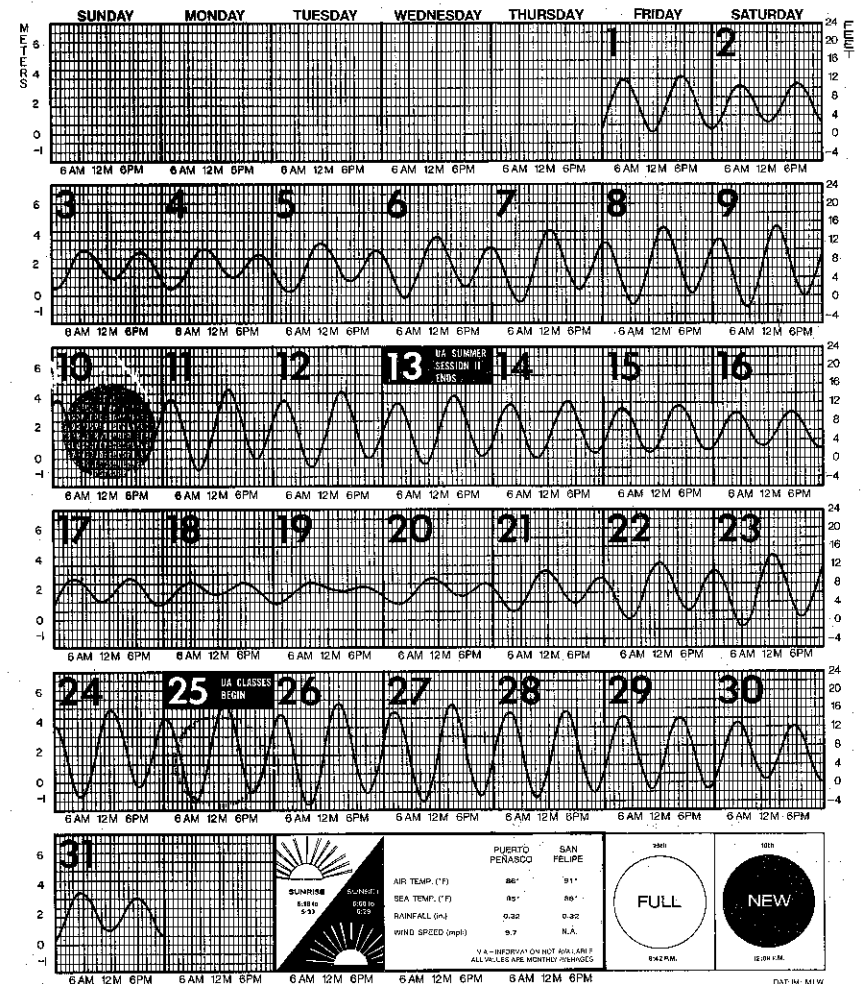
