



# SEARCH

On February 24th, around 5:00 P.M., a boat was reported overdue. The boat was last seen at 2:30 P.M. at the 18 mile reef heading back to Cholla. Augustine tried to reach Jim Wade, the missing boat captain, by marine radio2182, several times with no response.

Martine Taylor went to a high spot by Pelican Point and started scanning the horizon. About 7:20 P.M. he saw a light flash about 15 miles out on a 230 degree heading. Martine and I, with Rojo directing the search from the radio shack, launched our boats. It was a moonless night and after several hours of dodging shrimp boats in the pitch black the search was called off.

After we arrived on shore, Wally and I went to Ralph Smith's home to ask him if his plane was available for the search. Ralph said yes and he would be ready to fly around 6:30AM the next morning.

Saturday morning Ralph, Wally, Bob Thomas of the Phoenix Republic, and I left to search for Wade's boat. Ralph said that there was no available gas in Rocky Point so he only had 1 hours of flying time for the search and that would leave him enough fuel to fly to Nogales for more fuel. As we flew a search pattern over the area that Wade was last seen we saw nothing but pongas and shrimp boats. We returned to the airport and I told Augustin to alert all shrimp boats and any other boats that were going fishing. Also, La Playa De Oro was notified and any boats launched from there would be on the lookout.

At 9:30 A.M. I launched my boat with Hector Munro and Bob Thomas on board and headed towards the sand dunes. The winds picked up so we returned.

About 12:30 P.M., the commandante of the airport called on the radio and said there was another plane available with approximately 11/2 hours of extra fuel. The pilot Dr. Aranoff, his friend Dr. Hippert and I flew towards the double dunes as Bucky and Glenda Maude, Ralph and Phyllis Smith, Wally and others headed by land towards the shell cliffs. Again, no one saw anything. We all then returned to

to Cholla for a meeting about the search.

Bill Funkhouser told us that he had a contact in Phoenix and he would be able to get us enough available gas to continue the search. Ralph said he had enough gas for 12hours of flying and we should explore the Bird Island area. Ralph, Ed Perlmutter, Wally, Bucky and I headed south and saw nothing but more shrimp boats and pongas. The search was called off for the night.

When we returned to Cholla, Bill told us that Pierce Aviation would have 175 gallons of available gas in Cholla that Saturday night.

Early Sunday morning, Wally was on the VHF saying the gas was in Cholla and they were going to fuel the airplane. Ralph, Wally, Rojo, Jim Pierce, Bucky and Howard Larson flew up the shore line towards El Gulfo. As they were returning to Cholla, Jim Pierce saw a white object in the water about 12 miles out of Cholla on a 240 degree heading. It was the missing boat. Bucky said there were six grown men crying for joy in the airplane. The plane then returned to the airport to refuel.

Martine with Victor Manuel and I with Bill Funhouser and Bob Thomas launched in foul weather to rescue Wades Boat. We were about six miles out when Ralph's plane flew over and lead us to Wade's boat. When we reached the boat, we found everyone in good health and crying with happiness. Later we found that Friday, Wade headed towards the dunes by accident and ran out of gas. His battery was dead so his radio did not work. Saturday as the wind came up, he started dragging anchor and drifted south until we found him Sunday. We arrived in Cholla, where a large group of people welcomed Wade and his two companions home.

Thank you Ralph Smith for the use of your plane. It would have been impossible to locate Wade without your help. Also, thank you Wally, Rojo, Martine, Augustin, Ed Perlmutter, Bill Funhouser, Bucky Maude, Hector Munro, Jim and Boyd Pierce, Dr. Aranoff, the people in Cholla Bay and La Playa De Oro and the Mexican rescue(shrimp boats), for this search would have not been possible without you.

A very special thanks to the wives and girlfriends of the people who participated in this search as they saw very little of us during the three day search.

Surely you have some favourite recipe that has saved you at the last minute after fishing/working all day, or a recipe that was a smash hit with family & friends! Please share it with us.


We are short on helpful hints. Little tricks or improvisations to use at the Bay. Storing foods, first aid tips, etc.





Oh! come with me to Mexico by the beautiful Sea.






CRAB CAKES

1 egg
2 heaping tbs. mayonnaise
3 tbs. self rising flour
3 tbs. chopped fresh parsley
1 tsp. dry mustard
1/8 tsp. Worcestershire sauce
1 pound crabmeat
Salt
Freshly ground pepper
3/4 cup vegetable oil

Beat egg lightly in small bowl; stir in mayonnaise. Whisk in flour, parsley, mustard, and Worcestershire sauce until thoroughly blended. Add crabmeat; toss lightly. Season with salt and pepper to taste.

Heat oil in large heavy skillet over medium-high heat. Carefully drop batter, in 1/4 cup portions, into hot oil; flatten each portion slightly with spatula; fry until golden brown, about 3 min. Turn; fry until golden brown on second side, 1 to 2 min. Drain on paper toweling. serve immediately. Makes 10 crab cakes.



### 4. Registration and weighing of fish:




### 5. Derby Tickets:


