OPEN LETTER TO THE CBSC by Frank Paseka

When the 2005 fishing derby was winding down, I was heavily recruited to take the derby chairmanship for 2006. I accepted the job because I believed that I could take the derby forward from the high of the 50th year derby. Unfortunately I find that this is not true. I placed an article in the Chatter requesting feedback on two questions. The responses that I received showed a clear split on the issue of fishing for Grouper. The people that fish wanted grouper in the derby and the people that don't fish wanted grouper excluded.

Apparently a number of respondents felt that they needed to respond to a member of the board of directors versus me and that person did not feel that it was necessary to forward the information to me. Why, I do not know? While I was trying to find out what the CBSC members wanted and what the Mexican authorities mandate concerning the waters we fish in, a meeting was called to decide the issue. I find that this also took place last year when the joint chairpersons tried to discuss this issue with the CBSC board of directors and a deaf ear was also given to them. A meeting was called and a decision was issued totally ignoring local authorities and the derby chairpersons.


I spoke with both of the non-board members that attended this 10/22/2005 meeting. I was told that it was the boards "recommendation" that grouper be excluded from the derby. The Chatter states "the CBSC board decided again to not allow grouper" in the derby. The Chatter also provides a very nice article provided by Jen for publication. It also goes further and states "the CBSC board has asked the Derby chairs to continue excluding the grouper" from the derby. I do not know just what games people want to play, but I will not play them. I was never asked my opinion about anything or just what information I had obtained. The CBSC board has not contacted me about anything concerning this issue.

As a direct result of this, I respectfully submit my resignation as the 2006 derby chairman. I am not sure what the board of directors was looking for, but I am not it. For what it is worth - my survey indicated (by the people that fish) that the target fish was a good idea, not that any of my ideas were/are any good. I want to make a very plain statement. Sports fisherman have a impact, but no fish species has ever been placed on the endangered list by sports fisherman. In the last 100 years 90% of the oceans fishes have been depleted, should we stop fishing all together?

COUNCIL COMMENTS RE: OPEN LETTER TO THE CBSC (above article)

I am Council Secretary, and therefore would like to clear up a few points which Frank stated in his letter to the CBSC. Number 1 - Although I received some responses in regard to Frank's request (I assume he was referring to me), all of the ones that I received were copies of those which had been addressed to Frank and copies sent to me. Maybe others received the same emails also. I don't know. Since I was just "copied" I saw no reason to forward them to Frank. 2. We (Council) did not call a meeting to decide the issue of the grouper. Nor did the Council call a special meeting last year in that regard. We did, however, have a regular meeting, and at that time the subject was brought up and the Council felt that if it would endanger the species, it probably shouldn't be included. As a Sportsmen's Club, we felt that it would be the correct thing to do. We had not had the occasion to speak with Frank about the decision, since we did not know when Frank was or would be in Cholla. He did not contact us. As far as we know, the Mexican authorities do not prohibit the catching of grouper at this time, but the problem still remains that they are an endangered species. 3. No one is "playing games"

There were 30 + people on this team, not all pictured here. They are called the Rocky Point Mission Team. The team consists of men, women and children, dedicated to helping less fortunate people have a better life.

They supplied all materials, poured the concrete floor and foundation on Thursday, framed in the walls on Friday and finished off the walls, roof, doors and windows on Saturday. The only thing left to do was some more stuccoing on the outside, which some members of the family hopefully will do. That was a lot to accomplish in three days. The needy family was chosen by Esperanza de Vida, which is the organization that Connie White founded to help the people of Rocky Point after the hurricane Nora blew through here in 1997, and is located in the Colonia Nueve, north of the paved road into Cholla. They have a Bible Study every Saturday, and some of us from Cholla serve the food to them from time to time. Previously the family lived in a lean-to with dirt floors. Maria cried and laughed at the same time, so happy to at last have a home. The team was tired and sore, but very happy to have done God's work....
