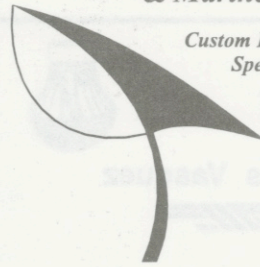

RE-CAP OF THE 2001 CBSC FISHING DERBY

The 2001 CBSC Fishing Derby was a mix of good and not so good. The "Good" is that the temperatures were mostly mild, with only one or two really "hot" days. The "not so good":

- The mild temperatures were caused by sea breezes which made for choppy seas and uncomfortable boating
- The Port of Cholla Bay was closed a couple of Derby Days due to rough seas.
- On days when conditions were more favorable, the sea breezes combined with tidal currents made drift fishing nearly impossible and anchoring difficult.
- Many boaters were not able to be in Cholla Bay on Fridays, when sea conditions seemed to be less uncomfortable.
- One boat sank and another nearly sank. Those on board, including two small children, were fortunate to be rescued by near by Ponga fisherman.
- There were no large groupers caught and a number of categories had no entries.
- Because of limited success by fisherman it was necessary to purchase fish for the Fish Fry

Other "Goods" were:

- A number of large sea trout and other fish were caught from shore.
- A 1-3/4 pound Pompano caught from shore by Randy Adams may qualify for a World Record
- At the "Pot Luck" dinner hosted the Cholla Chapter and at the "Steak Fry" hosted by the Phoenix Chapter there was good attendance and much camaraderie's among the Chapters
- The Fish Fry was well attend with over 800 dinners served
- The improvements to the Fry Shack have made it much more comfortable when serving large groups.
- CBSC has a Derby Chairman for 2002 who is already hard at work
- The Derby volunteers did a superb job and all went very smoothly
- There was a special award, a brief case with a City of Phoenix Police insignia, presented to Agustin Leon by Detective Steve Glasko of the Phoenix Police Department. It was given in recognition of the assistance Agustin has provided to Americans who find themselves in legal or medical difficulties in the Puerto Penasco area
- A plaque was presented to launcher Rosario Villa in recognition of his 21 (almost 22) years of service to Cholla Bay boaters. Villa began working for George Perez on July 4, 1979. He was frugal with his earnings and a few years later had his own launcher. If a disabled boat is being towed in at 3:00 in the morning Villa will be there. If a boat wants to launch at 4:00 in the morning heading for a distant reef, Villa will be there. Villa is always ready to help out.

How many of you know that there is an Air Medical Service available to Rocky Point? Today I had the pleasure of meeting Karen Gomes, Marketing Director of Air Medical Service operated by Sun West Aviation of Tucson. Some of you might have met her in Cholla a few weeks ago. She told me that she missed the Cholla Chapter meeting and was disappointed that she didn't have the opportunity to meet you there.

Karen has an extensive background in medical services and has met several of the doctors in Rocky Point in addition to an excellent relationship with the Red Cross. The cost is minimal, approximately \$3,000 to fly into Rocky Point, provide high tech medical assistance and air transport to a U.S. medical facility. If it means saving a life, it is worth every cent. This service is not limited to Rocky Point but has a wide range of destinations.

She is working diligently to obtain temporary night lighting for the Rocky Point Airport landing and would like to meet anyone who has any contacts or can help with this effort which would be a great humanitarian achievement. Presently flights in and out of Rocky Point are limited to daylight due to no lighting in the runways. 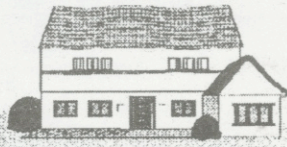

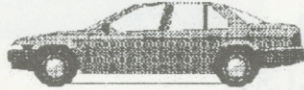

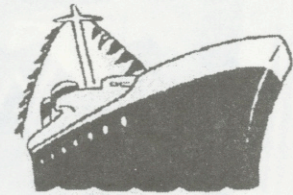
