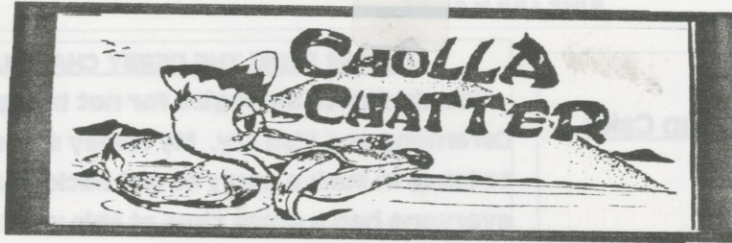


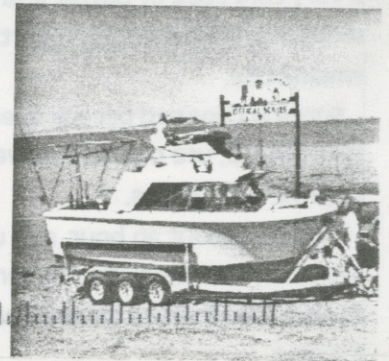

COOK'S CORNER

Hawaiian Surprise Dump Cake

Preheat oven to 350 degrees

In 9 x 12 pan - dump:

1 large can crushed pineapple, unsweetened
(do not drain - dump juice and all)

1 can cherry pie mix (you may use other kinds instead if you wish)

Sprinkle about half a package of yellow cake mix over this, evenly. Do not mix in.

With a small, thin-bladed knife, thinly slice a very cold cube of butter and layer the slices over the cake mix. Don't use the whole cube.

Sprinkle chopped pecans over the butter.

Don't skimp, use plenty to cover nicely.

Approx. 1-1/2 cups.

Bake for about an hour, and until the nuts are nicely browned. Can be served warm or cooled. Good with ice cream or other topping.
